Canterbury Primary School Council reviews the fee schedule annually and has given careful consideration to all aspects of school needs to provide an excellent educational environment for all students.

School Council makes every effort to keep the cost of items and activities to a minimum and affordable for all parents and advise that contributions for 2021 will remain in line with last year.

This year, the Department of Education is moving towards greater transparency for parents by reclassifying how fees are presented (see Fee Schedule attached).

We rely on your contributions and without the support of our families through your contributions (both Essential & Voluntary) and fundraising, Canterbury Primary School could not provide the quality and range of educational programs and resources that you and the school expect for your child. Thank you to all of those families who have made a contribution to our school, these funds have been gratefully received and allowed us to:

- Provide an enhanced curriculum to all students (ie: Maker Space - coding, 3D Printer, sewing, woodwork, robots) and Maker Kitchen
- Purchase digital technology equipment and provide a high level of IT Support (ie: Laptops, iPads, TV's, IT Technician)
- Purchase classroom resources (ie: Library books, class sets, readers, sporting and music equipment)
- Buildings (ie: main building verandah reinstatement, painting, carpeting, blinds)
- Grounds (ie: retaining wall and outdoor furniture replacement, synthetic turf maintenance, playground equipment maintenance)

Refunds

If a camp or excursion is cancelled or altered by the school, or a student is no longer able to attend part or all of the camp or excursion, our school will consider requests for partial or full refunds of payments made by parents/carers on a case-by-case basis taking into account the individual circumstances. Generally we will not be able to refund payments made for costs that have already been paid where those funds have already been transferred or committed to a third party and no refund is available to the school. Where possible, we will provide information about refunds to parents/carers at the time of payment.

Voluntary Contributions

Canterbury Primary School continues to welcome your voluntary contributions to support our school and programs. School Council gratefully acknowledges your generous contribution.

Learning Resources - contributions will be used to purchase quality learning resources, class sets, readers, sporting and music equipment.

Digital Technology Resources - contributions will be used to purchase technology equipment (ie: laptops, iPads, classroom TV's) and engage an IT Technician to provide high level IT support across the school.

Building Fund (tax deductible) - contributions will be used to undertake building development and school improvements. In 2021 these funds will contribute to the continuation of the internal painting and carpeting programs.

Library Fund (tax deductible) - contributions will be used to improve resources and upgrade the Library. In 2021 these funds will continue to update library books, resources and Library refurbishment.

Grounds - contributions will be used to employ a person to manage and maintain the school's grounds and facilities. DET funding is heavily supplemented by the school to ensure our grounds continue to be maintained in optimal condition. This contribution supports the work of the Buildings and Grounds Committee to improve facilities at working bees and eases the burden on fundraising activities. This enables the proceeds from such activities to be directed more towards improving facilities, equipment and learning opportunities for all students.

First Aid - contributions will be used to support the provision of a quality First Aid program.

Canterbury Parents Association - Annual family membership for the Canterbury Parents Association. These funds help support the community when required during the year. Your family membership will help the CPA support the school community in 2021 and will also allow voting rights at CPA meetings.
